This unique, one-year program is open to professional candidates in the public and private sectors. The Humphrey Fellowship Program is one of the U.S. government's most prestigious programs bringing accomplished young, and mid-career professionals to the United States for a year of non-degree graduate-level study, leadership development, and substantive collaboration with American counterparts, including first-hand exposure to the American work environment, providing a basis for lasting, productive partnerships.

Applications are invited in the following fields:

Interested applicants with a minimum of five years full-time professional experience in the field s/he is applying, may apply in one of the following fields:

- Agriculture & Rural Development
- Economic Policy & Finance
- Natural Resources & Environmental Policy
- Urban & Regional Planning
- Communications & Journalism
- Law & Human Rights
- Public Policy Analysis & Public Administration
- Technology Policy & Management
- Educational Administration, Planning & Policy
- Public Health Policy & Management
- Substance Abuse Education and Policy

Successful applicants must meet the following criteria to be eligible:

• Applicants must be Omani citizens.

• Applicants must be residing in Oman at the time of the application and during the entire selection process.

• Applicants much hold an undergraduate degree (BS or BA) of at least four years of full-time study and must have demonstrated academic excellence.

• Applicants must have a minimum of five years of full-time professional experience prior to August 1, 2025 in the relevant field. The work experience should be after completing a university undergraduate degree and should be within the field of study. Applicants should be interested in the policy aspects of their fields of specialization.

 Applicants must demonstrate leadership qualities and have a commitment to public service and the potential for professional advancement.

Applicants must be proficient in both written and spoken English.





Ineligible candidates:

• Recent undergraduate university graduates

• Individuals who have attended a graduate school in the United States for one academic year or more

• University Teachers or Academic Researchers with no management responsibilities, except in the field of Substance Abuse Education and Policy.

• Individuals with dual U.S. citizenship or U.S. permanent resident status may not apply to the program.

• Local employees of U.S. Missions abroad who work for the U.S. Department of State, or the U.S. Agency for International Development, including temporary employees and contractors, and members of their families as well as individuals who work for or are otherwise associated with an organization that is responsible for nominating or selecting individuals for participation in any ECA exchange program.
